- Playoff games will end a tie, if teams are tied at the end of regulation time.
- **Championship game** - tie at the end of regulation will result in 5 min OT.

  - 2<sup>nd</sup> Min 4 on 4 + Goalie
  - 3<sup>rd</sup> Min 3 on 3 + Goalie
  - 4<sup>th</sup> and 5<sup>th</sup> Min 3 on 3 no Goalies
